The principal agreement reached on 12 March 2015 was that advanced triage of Red Flag referrals would not necessarily be conducted. The main reasons for this conclusion were that:

- It has been found that it was too time consuming
- The other duties when urologist on call did not leave adequate time to undertake it
- An appropriate assessment of the need for advanced investigations often required, or was best made in, consultation with the patient
- The delay in consultation following advanced triage may jeopardise the patient's further management within the 62 day period.

A number of other issues relating to the triage of Red Flag Referrals were discussed and which may require definitive clarification. These were:

- If a Red Flag referral is downgraded from Red Flag status upon triage, that downgrading will be clearly made and the referral returned to the Office of Cancer Services. The Office will advise the Cancer Tracker of the downgrading?
- If another course of action is taken, such as a plan to have the patient attend a clinic of the triaging consultant (such as hot clinic or oncology review clinic) or a plan to have the patient admitted, then that plan should be communicated clearly to the Office of Cancer Services. How should this communication be conveyed? For example, should the letter of referral be returned to the Office even in the case of intended admission of the patient? Does the Office have an email address? The Office will advise the Cancer Tracker of the planned course of action?

In both of the above scenarios, it requires to be clarified whether the receptacle is the Office of Cancer Services, and the communicative relationship between the Office and the Cancer Tracker.
